FORM TO EXERCISE YOUR ACCESS, CORRECTION, CANCELLATION, AND OPPOSITION RIGHTS WITH RESPECT TO PERSONAL DATA

Protección Dinámica Agente de Seguros y de Fianzas, S.A. de C.V., ., having as its address that located at Avenue Periferico Sur number 5452, Olimpica, Coyoacan, Mexico City, Zip Code 04710, Mexico, hereby informs you that, according to what is set forth in Chapter IV of the Federal Law for the Protection of Data Held By Private Companies or Individuals, you are entitled to directly and at any time exercise your Access, Correction, Cancellation, and Opposition rights (**ARCO**, in Spanish) before the Company with respect to your personal data. Furthermore, we inform you that, in order to be entitled to exercise any ARCO Rights, the person making the request must necessarily be the Data Subject or its legal representative. In both cases, its legal status must be duly evidenced and documented.

ARCO rights are listed as follows with their respective definitions. Please place an “X” in the brackets corresponding to the right intended for enforcement. Then, in the lines being provided, please clearly and accurately state the information with respect to which you are requesting Access, Correction, Cancellation, or Opposition.

RIGHT OF ACCESS: Right of the Subject Data to request the Company to inform if there is any () information in its databases concerning its personal data, as well as the disclosures that have been made or are foreseen to be made with respect to such data.

RIGHT OF CORRECTION: Right of the Subject Data to request the Company to correct the personal () data in its databases when such data are incorrect, inaccurate, or have not been updated. It must show and provide a simple copy of the document justifying corrections.

RIGHT OF CANCELLATION: Right of the Subject Data to request the Company to cancel its personal () data recorded in its databases which are not required or relevant for the purpose for which they had been collected or recorded. It must specify the data required to be cancelled. Such right is subject to what is set forth in Article 492 of the Law on Insurance and Bonding Institutions.

RIGHT OF OPPOSITION: Right of the Subject Data to request the Company holding its personal data () to use such data in certain situations. It must specify the reasons for the opposition to such uses.

We will proceed to process your request not later than 20 (twenty) days following the date of the same. Please place an “X” in the brackets and we will inform you about the feasibility of your request through the means chosen by you:

Based on Article 35 of the Federal Law for the Protection of Data Held By Private Companies or Individuals, we remind you that there is no cost for exercising your ARCO rights. Nevertheless, Protección Dinámica Agente de Seguros y de Fianzas, S.A. de C.V. may request payment only for substantiated shipping costs or costs resulting from the reproduction of the information being requested by you, if required.
