Notice of Use of the Website

This Legal Notice regulates access and use of the website <https://www.protecciondinamica.com> that **Protección Dinámica Agente de Seguros y de Fianzas, S.A. de C.V.**, hereinafter **PRODISA**, makes available to users interested in the content enabled therein.

These are the Terms and Conditions applicable to the access and use of the **PRODISA** website (“the Site”) and the use on the Site by any person (“the User”).
